B Co Shot Gummies contains a combination of B vitamins which supports energy-yielding metabolism, and which plays a role in the maintenance of good health.

WHAT YOU NEED TO KNOW BEFORE YOU TAKE B Co Shot GUMMIES

Do not take B Co Shot Gummies if :

- You are hypersensitive or allergic to B Co Shot Gummies or any of the ingredients in B Co Shot Gummies.
- You are hypersensitive or allergic to cobalamin, cobalt or pectin
- You have a suspected but undiagnosed vitamin B12 deficiency
- You have Leber's disease or tobacco amblyopia.

WARNINGS AND PRECAUTIONS

Taking other medicines with B Co Shot Gummies

Always tell your healthcare provider if you are taking other medicines including complementary or traditional medicines as the use of B Co Shot Gummies with these medicines may cause undesirable interactions. If you have any medical condition, ask your healthcare provider for advice before taking B Co Shot Gummies, particularly if you are receiving a coronary stent or suffer from epilepsy. B Co Shot Gummies may interact with the following medicines: anticonvulsants, capecitabine, fluorouracil, levodopa and altretamine.

Pregnancy, breastfeeding and fertility

If you are pregnant or breastfeeding, think you may be pregnant or are planning to have a baby, please speak to your doctor, pharmacist or other healthcare provider for advice before taking this medicine.

Driving and using machinery

Taking B Co Shot Gummies does not affect your ability to drive or operate machinery.

Children and Adolescence

B Co Shot Gummies is not recommended for children below the age of 4 years. Consult a healthcare provider prior to use.

HOW TO TAKE B Co Shot GUMMIES

Always take B Co Shot Gummies exactly as described in this leaflet, or as your healthcare provider has told you. You should check with your healthcare provider if you are not sure. The usual dose for adults and children 4 years and over is 2 B Co Shot Gummies per day. For oral use only. Gummies to be chewed.

If you take more B Co Shot Gummies than you should

In the event of overuse, stop taking B Co Shot Gummies immediately and consult your doctor or pharmacist. If neither is available contact the nearest hospital or poison centre. If you forget to take your daily dose of B Co Shot Gummies, do not take a double dose to make up for forgotten individual doses.

POSSIBLE SIDE EFFECTS

B Co Shot Gummies can have side effects. Not all side effects reported for B Co Shot Gummies are included in this leaflet. Should your general health worsen or if you experience untoward effects while taking B Co Shot Gummies, please consult your healthcare provider for advice. If there is any hypersensitivity or gastrointestinal disturbance, stop taking B Co Shot Gummies and contact your healthcare provider.

If you notice any side effects not mentioned in this leaflet, please inform your doctor or pharmacist.

HOW TO STORE AND DISPOSE OF B Co SHOT GUMMIES

KEEP OUT OF REACH OF CHILDREN

Store at or below 25 °C.

Keep out of direct light and moisture.

Do not freeze.

Store in the original container.

Keep the container tightly closed.

Do not store in a bathroom.

Do not use after the expiry date stated.

Return all unused medicine to your pharmacist.

Do not dispose of unused medicine in drains or sewerage systems (e.g.: toilets).

PRESENTATION OF B Co Shot Gummies

B Co Shot Gummies are packaged in a labelled, sealed plastic pouch with a sealing strip. Each pouch contains 60 B Co Shot Gummies.
