# PHARMACOLOGICAL ACTION

Zinc is an essential element in the maintenance of good health. It supports a healthy immune system and the maintenance of healthy hair, skin, nails and bones. Zinc assists with the formation of connective tissue and in the metabolism of carbohydrates, fats and proteins.

Vitamin C is a well documented antioxidant and is essential for the maintenance of good health. Vitamin C assists with the metabolism of fats and proteins; assists with the maintenance of healthy bones, cartilage, teeth, gums and connective tissue; and helps with wound healing.

Vitamin D3 is essential for the development and maintenance of strong and healthy bones and teeth; normal cell division: the maintenance of neuromuscular function and the maintenance and function of a healthy immune system. Two capsules are to be taken daily after a meal with a glass of water. In cases of severe nutrient deficiency, daily dosage can be increased by a Healthcare Practitioner.

# SIDE FFFFCTS AND SPECIAL PRECAUTIONS

There have been no reports of major adverse events and side effects associated with any of the nutrients in the prescribed dosages

Isolated cases of nausea and vomiting have been reported. This can be alleviated by taking the recommended dosage after the main meal.

# KNOWN SYMPTOMS OF OVERDOSAGE AND PARTICULARS OF ITS TREATMENT

In cases of suspected overdosage, immediate withdrawal of the product is indicated and the treatment is symptomatic and supportive.
